

OGAG Meeting 5/1/2019

Wednesday, May 1, 2019 9:05 AM

The OGAG was created late in Mayor Gray's term. There was significant turnover with the change of administrations to Mayor Bowser particularly among government members. Many of Mayor Bowser's appointments date from June 2016. In June 2019 all the current public members terms expire. Although reappointments are possible, this is likely the last meeting of the OGAG as currently constituted.

Discussion:

What have been the strengths and weaknesses of the OGAG in advancing open government?

- Strengths
 - Mix of government and public members, and its role as a voice for transparency is the OGAG's super power.
 - Review of agency open government plans. (This was done when OGAG was first created and plans were created under the same Mayor's order)
 - Serving as a stakeholder group during development of the Data Policy.
 - Stakeholder list / tool ([link](#))
 - Willingness to take on and work through controversial issues.
 - OGAG review is helpful for agencies releasing new public facing applications and websites.
- Weaknesses
 - It is difficult for a mix of government and public members to deal with controversial issues.
 - Engagement with agencies beyond OCTO needs to improve.
 - Frequent changes in government members is disruptive, but perhaps inevitable.
 - Group should be more active in drafting and voting on resolutions.

What are the lessons learned about how to most effectively operate the OGAG?

- Maintain a cadence of frequent, but reasonably short meetings.
- Subgroups formed around impromptu issues are likely to be more effective than standing subcommittees.
 - That said, putting a particular subcommittee in charge the agenda for a particular meeting might be effective. This could be done on a recurring basis.
- Having procedures helps deal with controversial issues.

Advice for MOTA, what constituencies is it important to have represented on the OGAG?

- FOIA and Open Meetings
- Open Data
- Journalists (are an important group that hasn't been represented to date.)
- Not everyone needs to be an expert, ordinary residents can help.
- Note: current members are willing to help advertise and recruit new members.

How can we better engage agencies?

- OCTO gets high marks for participation, but the Group needs to do more to reach other agencies.
 - Work through the Deputy Mayors
 - Take a particular topic and invite particular agencies:
 - For example, topic is open budget and invite OCFO to present.

Suggested topics for next OGAG configuration to consider:

- PII/privacy, as the District considers these important topics OGAG has a role.
- Charter School openness, data and accountability
- DC's body-worn camera program in terms of what video is released under what circumstances.

- ANC openness and technology to support ANC meetings and websites.
- Budget transparency. What budget data is DC publishing and how are we publishing it?
- Be a place to validate the many erstwhile suggestions that come into EOM regarding public engagement.
- Engagement forums (such as budget engagement forums), what ideas does OGAG have to get the most out of these events?
